## **Slovene National Benefit Society National Board Minutes**

Meetings held Jan. 10 and Feb. 13, 2023, via conference call, and March 24, 2023, at the SNPJ Home Office, Imperial, Pa.

#### Minutes of the Conference Call Meeting of the Slovene National Benefit Society National Board

held Jan. 10, 2023

The meeting was called to order by President EVANISH at 1 p.m. with 13 National Board members and one Young Adult Representative on the call. Bro. Don SRNICK was absent from the meeting.

President EVANISH explained that one purpose of this phone call meeting today is to discuss terminating the SNPJ Employees Defined Benefit Pension Plan. On the call for this discussion were Sara DeFilippo and Beth Milanovich from our pension actuarial firm, DBZ, Inc.; our Society actuary, Joseph Steimla; and our independent auditor, Leo Hannah from H2R.

Sara DeFilippo began the presentation to the Board, explaining how a defined benefit plan works. She stated that SNPJ took gradual steps over the years to limit the liability of the plan to the Society. To terminate the plan, it must be fully funded – and in a low interest rate environment, this would result in a much higher cost to the Society, while in a higher interest rate environment, such as we are experiencing now, the cost is lower to the Society.

Questions by Bro. Maury SINAN.

Sara DeFilippo explains the summary and the attachments that have been provided to the Board. The proposed date of the termination is 3/31/2023, and a resolution stating such must be approved by 1/31/2023 and letters sent to all affected participants in the plan. The termination needs to be filed with the PBGC. She reviewed the liabilities as of the assumed payout date of 11/1/2023; however, we won't know the total liability until all participants elect an option.

Questions and comments by actuary Joe Steimla and Bro. SINAN. Sara DeFilippo then explained the summary of fees from DBZ for doing the termination process, filings and paperwork.

Independent auditor Leo Hannah spoke on the benefits of termination of the plan to the Society. He talked about cash flow and complimented Bro. Lawrence for the cash flow projections he provided. Mr. Hannah stated that he felt that based on those projections, the Society would not have to sell any bonds to cover the cost of plan termination. Bro. Robert LAWRENCE explained the cash flow projections he provided.

A motion is made by Sis. Joanna BAKER, second by Bro. Rick HERVOL, to approve the resolution to terminate the plan following the timeline provided by DBZ, Inc. The executives cannot vote on this motion. The motion is approved unanimously by the remainder of the Board members.

President EVANISH thanked Sara, Beth, Leo and Joe for being on the call, and for their presentations and comments to the Board.

With no objections, the Board went into Executive Session. With no objections, the Board came out of Executive Session.

President EVANISH stated that the next topic is the TEL program for 13- to 17-year-old members. There are currently only 18 elected TEL delegates. President EVANISH explained the promotion of TEL through Facebook, secretary mailings and *PROSVETA*. The numbers are not sufficient to hold the program.

Comments by Bro. Jason CADEZ, Sis. Tina RIGLER, Young Adult Representative Justin RIGLER, Bro. Fred MLAKAR, Bro. SINAN, Sis. Tracey ANDERSON, Sis. BAKER, and Sis. Karen PINTAR.

A motion was made by Bro. SINAN, second by Bro. CADEZ, to extend this discussion and the deadline for TEL to Feb. 13, 2023, while also having the Young Adults put together some type of program for assisting with TEL. Motion approved.

President EVANISH presented the Resolution adopted at the last Convention regarding the Young Adult Conference for 18-to 30-year-old members and a surrogate delegate being elected as a regular delegate of another Lodge. The Lodge would have to approve the surrogate delegate representing their Lodge as a regular delegate.

A motion is made by Sis. RIGLER, second by Sis. ANDERSON, to pay the full amount of travel costs, etc., to any surrogate delegate who is elected as a regular delegate of another Lodge, while any remaining surrogates would still be reimbursed half of the travel costs. Discussion by Sis. PINTAR, Sis. RIGLER, and Young Adult Repre-

sentative Bro. RIGLER. Motion approved.

#### Minutes of the Conference Call Meeting of the Slovene National Benefit Society National Board

held Feb. 13, 2023

The meeting was called to order at 1 p.m. by President EVANISH with 14 National Board members and one Young Adult Representative on the call.

President EVANISH brought up the discussion on the TEL program. He pointed out the costs involved with the program, the clearances that would be necessary for counselors, the additional insurance coverage that would be needed for this, and the overall risk and liability with hosting the program.

A moment of silence was held for all members deceased since the last meeting, and special mention was made of the passing of former Region 2 Vice President Bro. James Curl in October 2022.

President EVANISH conducted the installation of National Board members.

President EVANISH appointed Brothers Don Srnick and Maury Sinan to serve as vice presidents of the meeting with no objections. The Time of Sessions was approved as 11:20 a.m. to 5 p.m. with lunch from 12:30 p.m. to 1 p.m., with no objections.

Sis. Justina RIGLER motioned, second by Bro. Rick HERVOL, to approve the Order of Business. Motion approved.

President EVANISH reported that a Board education session was conducted by attorney Todd Martin from 9 to 11:10 a.m. today prior to the start of the meeting.

President EVANISH introduced Courtney Brophy from Wellington Management Company, our asset management firm. Courtney explained the three-person relationship team that is used for SNPJ, and she introduced Liz Kleinerman who joined us by video conferencing. Liz discussed the current market conditions and reviewed the Society's portfolio performance for the year.

President EVANISH thanked Courtney Brophy and Liz Kleinerman for their presentation.

President EVANISH continued the meeting, reminding all to be tactful and considerate when speaking. With no objections, the Board accepted all reports.

## National President's Report March 2023

Fraternal greetings, Brothers and Sisters. Welcome to our semiannual National Board meeting as we report and discuss the operation of our fraternal organization. We look forward to a positive and informative meeting with a valuable exchange of ideas for the benefit of the Society.

Retiring National Board member Bro. Jim Curl, who was recognized for his service during the Convention, sadly passed away on Oct. 15, 2022. In addition to his 30 years on the Board, he served SNPJ on the local level for seven decades, including SNPJ Sygan Lodge 6 as treasurer, president and secretary, also being recognized as a top SNPJ sales agent. He also served as the SNPJ Recreation Center director and on the Recreation Center Committee since 2003. It was great to work with Bro. Curl all of these years.

In July, upon the Executive Committee's recommendation, the Board approved to upgrade our current computer system as opposed to going into a new system. After working with our IT consultant and discussions with various insurance administration vendors, we determined that the best approach and most cost-efficient plan would be to upgrade the current system that we have using Illumifin, previously known as Genelco. There is a cost savings to upgrade the system as opposed to migrating to a completely new system, and also much less of a learning curve for all system users.

National Secretary/COO Karen Pintar is the leader on the computer system migration and upgrade project. She has put a tremendous amount of effort and work into making sure that it goes well. Karen participates in the biweekly project meetings with the Illumifin team and our IT consultant. This is in addition to her regular duties.

### Convention

The Society's 32nd Quadrennial Convention, held Aug. 15, 2022, took place at the SNPJ Recreation Center, Borough of SNPJ, Pa. A total of 129 delegates and National Board members participated in the proceedings which were completed in one day.

The delegates are to be commended for being an important part of the National Legislative Body of our fraternal benefit society. The body carried out the responsibility of amending and approving the bylaws of the SNPJ, as well as electing the National Board that will serve our Society for the next four-year period.

The convention officers included Chairman Bro. Joseph C. Evanish, and Vice Chairs Sis. Tracey Anderson and Bro. Rick Hervol. The most demanding job during the Convention was that of the recording secretary. Sis. Karen Pintar did a commendable job. The sergeant-at-arms was Bro. Ken Vogrig (138).

All officer and Board reports were presented and accepted. Our Society's key consultants addressed the delegation. These included Andrew Paone, CFA, managing director with Wellington Management, the firm that serves as the Society's asset manager; consulting actuary Joseph Steimla; and Leo Hannah, CPA and partner with H2R, the Society's independent auditing firm.

Consul General of the Republic of Slovenia Alenka Jerak greeted

the delegation and extended appreciation to SNPJ for all of the support, especially during Slovenia's declaration of independence in 1991. On behalf of the Slovenian government, she presented me with the Memorial Medal which was awarded for contributions to the American recognition of the independent and sovereign Slovenia. In 1991, I led SNPJ's efforts for this cause. She also recognized Joe Valencic (5) who previously received this honor.

Retiring National Board member Bro. Ken Anderson was recognized for his service to the Society. He served a term as a Regional Director and as a member of the Finance Committee since 1999, for a total of 28 years on the National Board.

Retiring National Board member Bro. Jim Curl was also recognized for his service to the Society. He served on the SNPJ National Board for 30 years as a Regional Vice President. Both Ken and Jim received standing ovations from the delegation.

The Young Adult delegates representing the SNRI Young Adult

The Young Adult delegates representing the SNPJ Young Adult Conference were Justin Rigler (449) and Jerome Petukauskas (33). Justin is serving as the Young Adult Representative to the National Board for this year.

The Executive Committee and Home Office staff worked diligently preparing all that was necessary for an organized an efficient Convention. Delegates were provided with the information necessary to perform the task of the Convention. I thank officers National Secretary/COO Karen Pintar and National Treasurer/CFO Bob Lawrence for their hard work to ensure that the arrangements were successful.

We also thank the Home Office staff for their help preparing all the necessary materials for the delegation. The successful efforts of Executive Assistant Peggy Cushman and Office Manager Ruth Wright, who also set up and staffed our onsite Convention office, were greatly appreciated.

There is a significant amount of work that goes into preparing for

a Convention, and Sis. Pintar led the organizational efforts of most of it, including the travel, lodging and food service arrangements. Our SNPJ shuttle driver, Frank Wright, did a great job taking care of our delegates, along with a limo service. Kathy Paulenich, Cathy Kalenits, Amy Mavrich and Kathleen Sinan assisted with the microphones during the meeting.

Our SNPJ Recreation Center staff and management, who include Director David Jones, Sue Krispinsky, Gary Ehasalu and Sue Zarella, did a commendable job preparing the facility for the Convention.

The Sunday reception at the Heritage Pavilion was a great success. This was a traditional picnic/dance with food prepared by Jones Catering with Strabane klobase.

Bro. Marty Kumer (715) got the last word of the Convention, although not by giving his usual articulate speech, but by leading the delegation in song to the lyrics of The Beatles "All You Need Is Love." It was a fitting ending with a wonderful message, in which he also provided a polka-beat version.

### Marketing

For the year 2022, the Society issued a total of 304 policies. The life insurance face amount for the year totaled \$5,694,145. The life insurance in force is now \$248,578,291. There were 222 new members enrolled during the year, compared to 226 the previous year. First-year annualized premium experienced an increase over the previous year. Annuity premium decreased to \$5,437,038 for 2022, compared to \$9,343,487 in 2021.

During this period, a personnel adjustment in the Sales Department took place. Currently, the sales function is being overseen by Marketing Manager Gina Wise. She does an excellent job working with and supporting the agents and agencies promoting the sale of SNPJ products. She has also taken on the duties of writing the *PROSVETA* insurance column "We've Got You Covered."

Gina continues to promote all aspects of the SNPJ through social media, enhancing our overall presence. Information about life insurance and annuities is consistently posted, along with SNPJ events and activities. She communicates regularly with agents, and provides updated promotional materials to agents, Lodges, members and potential members. Gina also stepped up to take charge of our Slovenefest membership booth during the weekend.

The rising interest rates had an effect on the annuity rates, including the guarantee rate. The minimum guarantee rate was adjusted from 2.0 percent to 3.0 percent on Jan. 1, 2023, for new issues.

The Lodge Bonus Program includes an incentive for new member enrollment. For every 10 new members enrolled, a Lodge receives a \$100 bonus. Congratulations to the following Lodges who earned bonuses: Lodge 31, Sharon, Pa.; Lodge 106, Imperial, Pa.; Lodge 603, Samsula, Fla.; Lodge 715, Universal, Pa.; Lodge 782, Glenshaw, Pa.

Lodge 6, Sygan, Pa., and Lodge 138, Strabane, Pa., both received \$200 bonuses for enrolling 26 and 23 new members respectively.

The commission improved the efficiency of the weekend program, which was well coordinated and planned. There were six contestants, with Madison Sinan, a member of Lodge 782, Glenshaw, Pa., being crowned Miss SNPJ 2023. Madison also was named Miss Activity and Miss Talent. Lanie Maresh (449) earned the runner-up titles to Miss Activity, Miss Talent, and Miss SNPJ. Cara Fabian (218) was named Miss Fraternalism.

SNPJ Family Week was also successful this past summer. The SNPJ Recreation Center staff did great job managing a fun weekend for all of the families that participated.

National SNPJ Days held Labor Day weekend saw good participation in the National Balina Tournament and National Beanbag Tournament. The National Golf Tournament was also held. The SNPJ National Athletic Board members, tournament leaders and volunteers made these tournaments successful.

For the 2022 National Golf Tournament, played at Stonecrest Golf Course, there were 11 men's teams, 46 individual men, and four individual women competing, resulting in a Society remuneration of \$658. The National Balina Tournament hosted 13 men's teams and 10 women's teams, resulting in a remuneration of \$644. The National Beanbag Tournament had 24 co-ed teams and 10 women's teams competing, resulting in a remuneration of \$476.

#### **Publications**

The SNPJ news source, the PROSVETA publication, is designed and managed by Editor Jay Sedmak. PROSVETA, which remains a monthly publication, is also available online. At present, approximately 950 members receive e-mail notifications that the current PROSVETA issue is available online. We certainly appreciate the contributions from our scribes who promote and report on SNPJ activities and events in their respective areas.

Following the 32nd Quadrennial Convention held in August, Jay completed the "Convention Proceedings and Reports of National Officers" books, as well as the Society's Articles of Incorporation/ Bylaws/Resolutions books, both of which were printed prior to the end of the year.

The Miss SNPJ calendar, which was reintroduced for 2023 when the Miss SNPJ Pageant was reinstated and held during Slovenefest in July, was also completed during this period. Along with the calendar, he also designed the Miss SNPJ Pageant brochures that will be mailed to all eligible female members (ages 18 to 28) in March/April 2023.

Throughout the period, Jay started the preliminary promotional work for Slovenefest, updating the flyers, the sponsor invitations and the online Slovenefest performance schedule, as well as the flyers and forms required for the "Make It, Bake It, Grow It" Crafters Bazaar. He also coordinated the repair and painting of the SNPJ Home Office exterior in July, working with the contractor and crew to ensure

completion of the project in a timely manner with limited disruption

to the staff and routine office deliveries.

### Industry

The Society stays in tune with the fraternal industry through a network of local, state and national trade affiliates. This includes Executive Committee participation in the Fraternal Societies of Greater Pittsburgh (FSGP), the Pennsylvania Fraternal Alliance (PFA), and the American Fraternal Alliance (the Alliance).

The Executive Officers continue to be active in the FSGP, and regularly attend the luncheon meetings that are held throughout the fall, winter and spring. The FSGP meetings include representatives of several fraternals headquartered or having a presence in Western Pennsylvania.

The Alliance Executive Summit meeting, which I attended, took place in person in September. This meeting gives us the opportunity to network with our fraternal benefit society peers, receiving valuable industry information. The Executive Summit took place in Washington, D.C., which also allowed for important visits with members of Congress, where we had the opportunity to promote the fraternal cause and help to retain our tax exemption. These were very successful visits.

I attended the Life Insurance Council (LIC) CEO Forum in August. LIC, a council of LOMA, serves the small to mid-size insurance company sector. The Alliance supports the LIC and offers discounted registration fees for its member fraternals to some of the key webinars/meetings. The forum offers an excellent opportunity to network with peers and receive updates on strategies in the insurance industry.

### Slovenia

SNPJ maintains a good relationship with Slovenian dignitaries, including the Consul General's office in Cleveland (Consul General Alenka Jerak) and the Embassy in Washington, D.C. We also work

closely with Pennsylvania Honorary Consul in Pittsburgh Petra Mitchell. Both Alenka and Petra attended Slovenefest, with the Consul General being a key speaker for the Miss SNPJ Pageant program.

Dr. Jure Žmauc, chairman of the Slovenian American Business Association (SABA), organized the visit of another Slovenian business delegation to the United States. I was happy to receive and meet with this group at our Home Office in September.

Jure also brought another gostilna chef from Slovenia, hosted by the SNPJ Slovenian Heritage Center Committee. This took place in October at the SNPJ Lodge 106 Hall in Imperial, Pa., coordinated primarily by Heritage Center Committee member Tracey Belle. It was very well attended and quite successful.

#### Conclusion

The Home Office management and staff are a dedicated group of people who work hard for the Society, supporting our membership on both the business and fraternal sides. We also appreciate the dedication of our Lodge officers for their contributions to the success of the Society.

The Society is fortunate to have an experienced COO and CFO. National Secretary/COO Karen Pintar and National Treasurer/CFO Robert Lawrence continue to do an excellent job for the SNPJ.

Executive Assistant Peggy Cushman continues to do a good job supporting the Executive Committee, handling regular projects and duties. She has been exceptional in taking on additional duties as necessary.

We look forward to beginning this term in a positive fashion. Congratulations to all Board members upon being elected to serve for the next four-year term. May our discussion and decisions provide for a strong and positive atmosphere for the good of our SNPJ. Fraternally,

Gina Wise has been doing very well in this position; and reported that he, Gina, and the consultant, who is the interim sales director, have been working on short- and long-term initiatives. He reported that Gina has been doing a great job with social media communication on Facebook and LinkedIn, and that a Fraternal Director, Sis. Courtney Koenig, has been hired.

Discussion on the report by Sisters RIGLER and Tracey ANDER-SON. Motion was made by Bro. HERVOL, second by Bro. Ken ZAKRAYSEK, to approve the report. Motion approved.

#### National Secretary's Report for the period July 1 through Dec. 31, 2022

Fraternal greetings, Brothers and Sisters, and welcome to the semiannual meeting of the SNPJ National Board.

The following report relates to the activities and business conducted through the office of the National Secretary for the period shown above. Additional information is included, where appropriate, for the entire year 2022.

### **SNPJ HOME OFFICE**

### Personnel

The Home Office employs 11 full-time individuals at the end of 2022, including the three executive officers, and one part-time individual. We continue to actively look for one additional full-time employee and one part-time employee for the insurance administration area. Our longtime employee in policy services, Cynthia Mitchell, retired

during the period after almost 29 years of service with the SNPJ. Her contributions to the Society and her knowledge of her job were invaluable to the Society over these many years. We wish her good health and happiness in her retirement.

### **Insurance Administration**

The individuals in administration have been very busy over the last six-month period. As a result of the roll out of new annuity products with new guaranteed and current interest rates, a lot of testing had to be done to verify interest rates on the new policies, check that commissions were being paid properly, and a variety of other testing procedures that occur with every new plan code that is instituted.

In addition to their normal job processes, they comply with quarterly audit requests for information from our annuity reinsurer, they assisted with the Convention prep work, and provided the necessary information to our independent auditor's December review of work processes and functions.

As we prepare for the upgrade to the new insurance administration system and the shift in job responsibilities for certain individuals, we have been focused on the re-distribution of work processes among employees while still recruiting for another full-time employee.

### **IT Department**

There has, of course, been a lot of activity in this area. We negotiated and signed the contract for the upgrade to the insurance administration system by the end of September 2022. Once that was finalized, the work on the system began in earnest. Our IT consultant and I work almost daily on this upgrade, and we hold biweekly meetings with the team from our software provider.

Since we will be hosting the majority of our computer operations off-site in the future, preparations are being made to set up servers and the necessary equipment at the host environment for both the insurance administration software as well as the accounting software used. We also signed on for a perpetual license for the accounting system that will allow us to use the current accounting software for as long as we want to.

In addition, the work has been started to implement a new Synology device for our network infrastructure upgrade. Prior to the end of the year, we worked on the implementation of the Multi Factor Authentication (MFA) to the insurance administration software with our managed services company so that our members' data would have an additional level of security. By installing this, we were also able to keep our cybersecurity insurance premiums at a reasonable level. During this period, several of us have begun using Microsoft Teams as a collaboration tool with plans to have all employees trained in the use of this.

We are working on the planning process for the transition of the e-mail from the current provider to Microsoft Outlook, and plan to have that process completed sometime in 2023.

### **LODGES AND LODGE SECRETARIES**

#### Lodges

As of Dec. 31, 2022, there are 71 Lodges. There was one Lodge merger during the last six months when Lodge 107, St. Louis, merged into Lodge 34, Indianapolis. We thank the longtime officers of Lodge 107 for the many years of service that they dedicated to the Lodge and to our Society, and we thank Lodge 34 officers and members for accepting them in a merger.

#### National Secretary's Report

Fraternally,

Sis. Karen PINTAR highlighted her report, explaining the various projects that have been worked on and processes implemented, such as the multi-factor authentication, the plan code updates for the annuities, as well as the fund updates for the changed interest rates on annuity products. She reported on training the staff in the use of Microsoft Teams, the transitioning of the servers, the updated program information for the RMDs to align with the Secure Act changes and the replicated database, and the contract negotiations that took place with the software provider.

Discussion by Bro. ZAKRAYSEK and Sis. RIGLER. Motion by Bro. Roger CLIFFORD, second by Bro. HERVOL, to approve the report. Motion approved.

President EVANISH then introduced Leo Hannah of H2R, our outside auditor, for his report. Leo introduced Cara Colavita as the lead on this audit. Leo stated that they issued a clean opinion on the audit; assets are up \$1.1 million, annuity considerations were down about \$3.89 million; the cost of the software conversion brought revenue down for the year. He stated they reviewed the financials during the course of their audit and the processes of the employees; he reviewed the liabilities and surplus with the Board. Leo thanked the officers and staff at the Home Office for providing all of the information necessary to conduct the audit.

#### **National Treasurer's Report** March 2023

Fraternal greetings, Brothers and Sisters.

Financial results show continued growth in assets while surplus decreased for the year 2022. The Society's assets increased \$1.2 million, or 1.0 percent, from year-end 2021 to total \$128,754,673. There were no significant changes to the Society's assets from yearend 2021. Fixed income securities and cash totaling \$121,514,703 represent 96.6 percent of the Society's total invested assets. Real estate holdings, which includes the Home Office and the SNPJ Recreation Center, totals \$1,918,963, representing 1.5 percent of invested assets. The remaining 1.9 percent of invested assets is comprised of certificate loans, mortgages, and other invested assets.

The Society experienced a \$140,916 loss from operations before refunds and capital gains and losses in 2022. Net income for the year after refunds and after realized capital gains and losses was a loss of \$229,300. Gross income for 2022 totaled \$12,791,577. The Society experienced a 42 percent decrease in annuity premium from the prior year. With short-term rates dramatically increasing, annuity considerations decreased as short-term investment offerings were very competitive. Life insurance premium was flat from 2021 to 2022. Gross investment income increased 1.7 percent from the prior year.

Insurance and annuity benefit claims increased 21 percent from 2021 to 2022. Death benefit payments on life insurance increased significantly by \$331,370, or 20 percent, from 2021 to total \$2,013,608. Annuity benefit payments increased by 22 percent over last year. General and fraternal expenses increased \$258,336, or 13 percent, from 2021 to 2022. Costs associated with the conversion of the insurance administration software system accounted for the increase. Insurance taxes, license and fees increased \$54,899, or 40 percent, over 2021 due to the increase in the cost of the Pennsylvania Insurance Department five-year examination over the prior examination cost.

The Society's surplus position decreased \$943,490, or 7.0 percent, from year-end 2021, totaling \$12,054,723 as of Dec. 31, 2022. A major factor for the decrease is the accounting for the computer conversion cost. The contract with the software company was executed in 2022, and the total cost of the conversion project is reflected as a decrease to surplus. Also affecting surplus is the transition of the Asset Valuation Reserve (AVR) to more granular reserve factors which is acting to increase the ultimate reserve to be carried on the Society's balance sheet. As of Dec. 31, 2022, the Society's asset-to-liability ratio is 110.3 percent.

#### **National Treasurer's Report**

Bro. Robert LAWRENCE highlights his report by explaining the operations loss due in part to the increase in death claims of \$331,000 and the cost of the computer upgrade of \$250,000. He also pointed out that the Society paid the Pennsylvania Insurance Department \$244,000 for the cost of the five-year examination. The change in surplus was also directly related to the cost of the computer upgrade. Actuary Joe Steimla explained how surplus was affected by the cost

of the computer upgrade. Motion by Bro. Jason CADEZ, second by Sis. Joanna BAKER, to

approve the report. Motion approved.

President EVANISH introduces Joseph Steimla, the Society actuary. Joe talked about the increase in death claims and its effect on income, the interest rate increase and its effect, and stated that the valuation interest rate is 4.25 percent and anything credited over that amount has to be reserved at a higher amount. He explained how selling more business helps with this. He reviewed the Asset Adequacy Analysis provided to the Board and explained the various scenarios involved in testing.

#### Finance Committee Report July 1 through Dec. 31, 2022

Wellington Management Company, LLP, continues to monitor the portfolio and manage the assets within the guidelines set forth by the Finance Committee and approved by the National Board. The Finance Committee works with the asset manager to determine appropriate risk measures for the portfolio with the goal of optimizing the portfolio yield while maintaining a high quality portfolio and matching the Society's liability cash flow needs. The low interest rate environment over the past decade made it very challenging when trying to cover current contract guarantees without taking on excessive amounts of risk.

During 2022, Treasury yields increased substantially. While yields increased across all maturities, shorter maturity US Treasury bonds saw a more dramatic increase, shocking the market. The benchmark 10-year Treasury rate, which was at 1.52 percent at the end of 2022, increased to 3.96 percent on Dec. 31, 2022, while the two-year Treasury yield increased from 0.73 percent at year-end 2021 to 4.73 percent as of Dec. 31, 2022.

During the six-month period, the book yield on the portfolio increased slightly, from 4.57 percent as of June 30 to 4.58 percent as of Dec. 31, 2022, while maintaining an S&P weighted average quality rating of A. The effective duration of the portfolio as of year end is 8.1 years.

Investment yields on purchases made in the second half of 2022 averaged 5.26 percent. Investment purchases for the six months had an 18-year average life with an average S&P credit quality of A.

Our committee extends best wishes to former Finance Committee member Bro. Ken Anderson who retired from the National Board at the end of 2022 after serving 24 years on the Finance Committee. He also served a term as a Regional Director prior to serving on the Finance Committee.

LAWRENCE mentioned the multi-asset income fund that the Society invested in, and how it initially paid a monthly income of six percent but is now paying between seven and eight percent. ### **SNPJ Audit Committee Report**

July-December 2022 Date of Report: March 23, 2023

Fraternal greetings, SNPJ Executive Committee, SNPJ National

Board and SNPJ members.

The Audit Committee met in the Home Office March 22-23, 2023,

for their semiannual meeting. The semiannual review consisted of routine documentation review and interviews with the Executive Committee.

#### **Routine Oversight Report Reviews**

The following were reviewed for the period July through December 2022:

- Review necessary invoices
- Receipt review of Executive Committee and National Board members
- Review checks over \$20,000

Note: These reviews were done at the SNPJ headquarters by committee members Joanna Baker, Vincent "Babe" Baselj and Ken Zakraysek; all was found to be in order.

#### **SNPJ Financials**

As with most fraternals, because of the current financial environment we are holding our own; however, revenue is down, death claims were up by \$300,000 this year, and there was also an increase in computer-related expenses and fraternal expenses. Operational expenses are over and above what we're bringing in, mostly due to the computer upgrade. We also had the expense of the National Convention in 2022, which isn't an annual expense. We've done a good job of cutting costs, but some were unavoidable. The Recreation Center is trending up, which we expect to continue, as events and weddings are up considerably this coming season.

#### **Charter Review**

The committee completed their review of the charter and recommends the following change to be consistent with the current bylaws: Under "Committee Composition," wording be revised to read: "An Audit Committee consisting of three (3) members elected by the National Legislative Body, of whom one shall be chairman elected by the committee."

### **Pension Plan**

In previous years, the Board has approved actions to reduce or limit the cost and liability of the Employees Pension Plan. Generally, higher interest rates decrease the cost to terminate a defined benefit pension plan. Interest rates have increased significantly in recent months providing a better opportunity to consider termination. In January, the elected Board decided to move ahead with terminating the plan. It is understood that this will not affect the benefit amounts for all pensioners and participants.

The IT upgrade to the insurance administration system is still ongoing, to be completed in the fall of 2023. Secretary Pintar is our project manager and is meeting with the Illumifin project team biweekly to make sure all SNPJ systems are covered and that the project is successfully completed.

### **Executive Committee Meeting**

On Wednesday, March 23, 2023, the Audit Committee met with the Executive Committee as a group to discuss any common issues such as status of weddings and events, solar farm, needed maintenance, etc.; also, sales, RBC, the pension plan, and current and anticipated future expenses. President Evanish will go over these items in more detail for the Board.

### **Lodges and Membership**

New membership is about the same as last year. An insurance sales and distribution consultant has been engaged to help review our sales and distribution process, and offer initiatives to help improve sales and new member growth. He is serving as the "Interim Sales Director" and working closely with President Evanish and the marketing manager.

Annuity interest rates and minimum guarantee rates were adjusted upward due to the significant increase in market interest rates.

### **SNPJ Recreation Center**

The committee reviewed the SNPJ Recreation Center Committee audit report which covered 2022. This is an audit of the internal control procedures at the SNPJ Recreation Center to ensure that proper procedures are being followed.

The Forest Management Plan prepared by the forester generally describes how the property could be managed to properly harvest timber while promoting and sustaining quality forest for years to come. If managed appropriately, another harvest would be timed 10-15 years from now. The first timber sale is taking place in the first quarter of 2023.

The Recreation Center has engaged an engineer to advise on how best to address maintenance requirement needs and upgrades to the waste treatment plant. To mitigate well pump failures, well system projects are being addressed.

There will be a reduction in the property assessment due to our appeal. This was after a significant increase.

The Recreation Center was host to the Convention. Slovenefest returned after two years and was very successful.

#### **SNPJ Heritage Center Report** March 2023

The 2022 season started with a teleconference call meeting on Jan. 15 with the planning of our summer season. We were excited to meet and discuss events as our busy season returned this year with Covid under control. We continued meeting via teleconference call on March 5 and April 9 since Director Kathy Paulenich spends the winter months in Florida as a snowbird until the beginning of May. This method of meeting has worked for the committee.

#### **SNPJ Recreation Center Committee Report** March 2023

This report covers the second six months of 2022. Our key full-time staff members include Director David Jones, Operations Manager Sue Krispinsky, Maintenance Manager Gary Ehasalu, and secretary Susan Zarella. Director Jones, our key staff members, and the parttime and seasonal staff do a commendable job operating our facility.

Cabin rental income experienced an increase over last year; however, still below pre-pandemic levels. Family Week was successful. Other groups also help with cabin revenue.

The SNPJ Convention was hosted at the Recreation Center in August. There were 129 delegates and Board members who took part in the meeting. Several delegates stayed onsite in the cabins and their trailers. The meals and social events supporting the Convention went well. We thank the Recreation Center management and staff for doing a great job. Jones Catering did an excellent job providing the necessary food for the group. A major donation to the Cabin Renovation Fund of \$25,000 was received during the Convention from SNPJ Lodge 41 in memory of Lodge President William Volker, as presented by Lodge Secretary/Treasurer JoAnn Raspotnik.

It was good to see the full return of our National SNPJ Days on Labor Day weekend this year. The SNPJ Slovenian Heritage Center covers the cost of entertainment. The Sunday picnic is a free-admission event. This, and all of the sporting events, were well attended and successful throughout the weekend.

Slovenefest was brought back for 2022 after being canceled for two pandemic years. We appreciate all of the hard work from volunteers and the staff. Kathy Paulenich did a good job putting together the entertainment. Ruth Wright was very instrumental in coordinating craft vendors for the weekend. Slovenefest cannot be successful without the nearly 100 volunteers. Director Jones, management and staff did a commendable job organizing the weekend after a two-year hiatus. Vesper Energy gave a \$5,000 Supreme sponsorship. Slovenefest was profitable and successful for the Recreation Center.

Director Jones brought back a variety of entertainment on Friday nights throughout the season in the Gostilna, with bingo on Saturday nights. The Gostilna and Tiki Bar increased revenue over 2021; however, still lower than previous levels.

Pool admissions increased over last year. However, the cost to operate the pool increased much more than the admission revenue increase. The manpower cost has escalated.

Operations Manager Sue Krispinsky continues to do a great job managing the wedding events. Jones Catering also does an excellent job providing quality food and service for weddings and fraternal events. The Heritage Pavilion is experiencing more bookings for weddings with the addition of the restrooms. The wedding business was stronger and experienced an increase over the previous year.

Well failure occurred on July 11, causing an emergency water shutdown of the trailer court and cabins. Things were re-opened on July 15. The emergency repair of the well came in at a cost of \$9,815.49 from Dillan Well Drilling. The consensus between management and the engineer to help resolve the reoccurring problem of replacing the Goulds 150H liquid-end of the well operation is to install a soft start control to prevent the pump from starting at full speed in response to lower water pressure. A Dillan Well Drilling soft start control proposal of \$5,167.50 was approved to be installed by year-end. It was also agreed to get further information on the pitless adapter replacement proposal from Dillan. We did receive an \$800 community grant from Vesper Energy for this project.

Heritage Pavilion Restrooms: The National Board approved \$127,750 plus a \$20,000 contingency for a total of 147,750. Currently, the expenditure is \$145,595, which includes the original base of \$127,750 plus \$12,756 for additional fixtures, water line, sanitary line, drain line to the building and pavilion, and electrical service. It also includes an additional \$5,089 for HVAC to the bridal suite. Some of the line that was installed was originally going to be completed by the Recreation Center. The restrooms were operational for Slovenefest.

During the weekend of July 23, several volunteers from the trailer court completed a number of projects. These included painting the mini-putt, re-doing the balina court playing surfaces, removing brush behind the lake, power washing the playground, etc. The committee very much appreciates these successful volunteer efforts. At different times during the season there were a number of volunteers who helped with special projects, or just lent a hand or their expertise, which we greatly appreciate.

A mid-year re-assessment of the property was done in 2021 which resulted in an increase to our property taxes where the assessment increased from \$3,160,200 to \$3,641,400 on the main parcel. This was appealed and will result in a reduction from the re-assessed amount of \$3,641,400 to \$3,262,700. We received this notification on Oct. 21, 2022.

The committee engaged a forestry consultant to prepare a forest management plan for the property. The plan generally describes how the property could be managed to properly harvest timber while promoting and sustaining quality forest for years to come. If managed appropriately, another harvest would be timed for 10-15 years from now. It was decided to proceed with the plan utilizing the forester who will manage the lands in accordance with accepted forestry best management practices.

The committee conducted a review of the internal control procedures at the SNPJ Recreation Center. This continues to be a normal business practice by the committee to ensure that proper procedures are being followed.

While we experienced an improvement financially over the previous year, lingering effects of the pandemic were still felt. Revenue was still down from 2019. The following is a summary of the year-end financial report for the year 2022:

Total Revenue	\$1,062,723
Total Expenditures	(\$1,251,653)
Net Loss	(\$188,930)

A detailed financial report is attached. It is noted that \$128,875 of miscellaneous income was received due to the employee retention credit (ERC) which was part of the CARES Act. This reduces the net loss above and is shown in the profit and loss statement. SNPJ's CPA auditing firm, H2R, was helpful in applying for this funding. The 2023 budget is also included as an attachment.

Honorary committee member Jim Curl, who passed away on Oct. 15, 2022, will be missed. He was a former director, a committee member since 2003, and a 30-year SNPJ National Board member. His contributions over the years to the Recreation Center are immeasurable.

We are very proud of our facility and property. Everyone is encouraged to take advantage of our beautiful SNPJ Recreation Center as we continue promoting our fraternal activities and programs.



## What I didn't know then

everal years ago I heard one of my favorite speakers/authors, Joyce Meyer, say: "We live life forward, but we understand it backwards." I never found this to be truer than when I was thinking about my deceased grandfather recently and the monthly outings we used to take together.

### Slovenian aerospace companies visit the U.S.

COLORADO SPRINGS, Colo. (STA) — In late April, a delegation of 10 Slovenian aerospace companies visited the

U.S., presenting their businesses at the Space Symposium Conference held in Colorado Springs. As part of the conference which,

according to the Slovenian Economy Ministry, featured some 18,000 participants, the companies were presented in a joint display. Company representatives also held meetings with U.S. aerospace companies and institutions.

The Slovenian delegation - led by Tanja Permozer, director of the Slovenian Space Office, which operates within the Economy Ministry – held a meeting with representatives of Axiom Space, a company that is building the first private space station and which launched the first private mission to the International Space Station last year.

Permozer also held talks with Colorado Lieutenant Governor Dianne Primavera, to whom she presented the ministry's plans for supporting further development of the Slovenian space program. "While some Slovenian companies are already successfully collaborating with the U.S., there are many more opportunities for strengthening cooperation in this field," Permozer was quoted as saying by the ministry.

Prior to the conference, the Slovenian delegation visited the Space Information Sharing and Analysis Center (Space ISAC) in Colorado Springs. The main mission of Space ISAC is to provide members and global space programs with timely and accurate information, via data sharing and analysis, to manage risk, especially the risks related to cybersecurity. "As Space ISAC is continuously expanding its network of members, they invited the [Slovenian] companies to join in," according to the Economy Ministry.

The Slovenian delegation continued its tour of the U.S. by visiting the research center at the University of Colorado Boulder in Denver.

#### Maribor Police HQ home to bee colonies

MARIBOR (STA) — In mid-April, the first "Slovenian police bees" flew out to gather nectar and pollen in Maribor City Park after the rooftop of the city's police headquarters provided a new home to four bee colonies.

"Bees are not only a common sight in village meadows; they are also welcome in cities, making their homes on the roofs, terraces, balconies and gardens of public and private buildings, and on the roofs of police organizations abroad, so we decided to invite four bee colonies to our rooftop," the Maribor Police Department announced.

The Maribor Police Department erected the beehive on the roof of their building near the City Park. The hive honors the beekeeping tradition in the region and draws on the expertise of beekeepers within the police force. "The project strengthens cooperation among our employees, as well as with police organizations and retired colleagues, many of whom have actively contributed to the project," a department representa-

"This honey story is much more than just an act of social responsibility for Maribor Police officers. Bees teach us about cooperation and mutual assistance; values that have brought together police department employees, our retired colleagues, family members, and members of professional organizations," said Maribor Police Department Director Donald Rus, who is a beekeeper himself.

Members of the Alojz Greif Hoče Beekeeping Association were also involved in the project, helping to construct the beehive and contributing materials and expertise. Painted by a retired Maribor Police Department employee, the beehive panels depict police work in a lighthearted manner.

#### New nature park opens in the Ljubljana Basin

LJUBLJANA (STA) — In early April, the Slovenian government established a new nature park in central Slovenia. The park encompasses the Češniške Gmaine and Prevojske Gmajne forests, which are among the last naturally-preserved, continuous lowland forests in the Ljubljana Basin and home to species that are nearly

extinct elsewhere in Europe. The new nature park spans 411.36



hectares (1,016 acres) of land in the Domžale and Lukovica municipalities. According to information provided by the Ministry of Natural Resources and Spatial Planning, the area is highly biodiverse, and its habitats offer shelter to species that are either endangered or protected in Slovenia and Europe.

The area includes less common wetland ecosystems, the largest of which is the floodplain of the Rovščica stream, a prime area for black elder growth. It also boasts three transitional mires - a very rare habitat in Slovenia - and several smaller wetlands.

The nature park will help preserve the continuity and complexity of lowland forests in wetlands, maintain the area's biodiversity, and protect the area's flora and fauna. Developmental goals include promoting the sustainable use of natural resources, enabling people to visit and experience what the park has to offer, curbing any negative environmental impacts, and allowing for future research and educational activities.

Protective measures will be introduced to ensure the continuation of forest, pond and agricultural land management by limiting construction and other acts affecting nature, such as deforestation and pollution.

#### Ljubljana hosting its first ballet festival in June

LJUBLJANA (STA) — The Cankarjev Dom cultural center and the Ljubljana Opera and Ballet House will host the Plesne Noči (Dance Nights) in late June, the first of what they hope will become an annual, international ballet festival.

This year's Plesne Noči will be dedicated to Rudolph Nureyev, who died 30 years ago. Running from June 22-26, the festival will feature dancers from the Ljubljana and Maribor ballet ensembles, as well as guest performers from Sofia, Bulgaria, and Belgrade, Serbia.

Uršula Cetinski, director of the Cankarjev Dom, has attributed the idea for the festival to the fact that creativity is peaking for Slovenia's two most successful ballet ensembles, the Ljubljana Opera and Ballet and the Maribor National Theatre. In addition, the demand for tickets to "Giselle" staged at the Cankarjev Domin January indicates that "audiences are thirsty for art," Cetinski said as she introduced the festival to the press.

The festival will include a performance of "Don Quixote" by the Sofia Opera and Ballet; the triptych "Myth, Rain Dogs, Aperture" by the Maribor National Theatre ensemble; and a ballet production inspired by "Ko To Tamo Pjeva" (Who's Singin' Over There?), a cult Yugoslav film from 1980, performed by the Belgrade National Theatre. The festival will close with the Liubliana Opera and Ballet House ensemble performing "The Great Gatsby."

### Film award now honors both Badjura filmmakers

LJUBLJANA (STA) — The Metod Badjura Award for lifetime achievement in film has been renamed the Milka and Metod Badjura Award in an effort to rectify the often overlooked contribution of Milka Badjura as a pioneer of Slovenian cinema and the joint creative power of the Badjura couple, distinguished by their creativity, perseverance and passion for cinema.

The renaming was promoted by a number of expert bodies and individuals, and has now been approved by the council of the Slovenian Film Centre to "reunite the most important Slovenian filmmaking couple, whose work often cannot be treated separately." It also "symbolically affirms Milka Badjura as a deserving Slovenian filmmaker and gives her a rightful place in the history of Slovenian cinema," the Slovenian Film Centre wrote.

The Metod Badjura Award for outstanding achievements in the field of film was first awarded by the Slovenian Filmmakers' Association in 1973. Since 1995 it has been awarded for lifetime achievement in filmmaking; the ceremony takes place each year during the Slovenian Film Festival.

Milka Badjura (1902-1992) was a Slovenian film editor and director who belonged to the pre-war pioneering generation of filmmakers and is considered to have laid the foundations of

Slovenian film production. Prior to the Second World War, she and her husband, Metod Badjura, made around 30 short films, mainly ethnographic and cultural films, as well as the feature film "The Slopes of Triglav" (Triglavske strmine). The Badjuras also deserve credit for producing the first film footage of ski jumping in Planica (1934).

As a movie editor, Milka Badjura contributed to a number of award-winning films directed by her husband. She was involved as editor on 13 additional feature films after her husband's death, including the classic "Vesna" (1953). She also directed a few movies, and received the Prešeren Fund Prize in 1968. Before retiring, she worked as film editor at TV Slovenija.

#### Alma Karlin Hall opens in Cankarjev Dom Centre

LJUBLJANA (STA) — A new venue named for author and globetrotter Alma Karlin (1889-1950) opened at the Cankarjev Dom Arts and Congress Centre in mid-April. The new 400-square-meter (4,300-square-foot) hall with panoramic views of Ljubljana will be intended for art exhibits, small theatrical events, concerts, and literary evenings, Cankarjev Dom Director Uršula Cetinski said.

Construction of the new hall, which cost more than a half million euros (\$552,000), excluding furnishings, was seven years in the making, mainly due to fundraising. "Originally, the space was a terrace that was closed in with windows in 2008," Cetinski told the press prior to the opening ceremony. "A year ago, this was an empty space with no wiring, no heating, and no equipment for sound, video, light[ing], so the project was not really a renovation, but actually construction," she added.

This new addition increases the number of stages in the 36,000-square-meter (387,500-square-foot) Cankarjev Dom, Slovenia's largest arts and cultural centre, to seven, and it is the first hall in the center to have been built in an environmentallyfriendly manner, Cetinski said.

Architecturally, the hall was inspired by an original idea of Edvard Ravnikar. Ravnikar designed the Cankarjev Dom, which was completed in 1982. The architect of the new hall selected only sustainable and environmentallyfriendly materials and elements – the chairs, for example, are made from recycled plastic bottles.

The hall opens up into a modern interpretation of the agora [an open public space], which together with the round stage pays tribute to the antiquity and theater of ancient Greece.

The opening ceremony was attended by President Nataša Pirc Musar and Culture Minister Asta Vrečko, both of whom lauded the decision to dedicate the hall to a woman. President Pirc Musar noted Karlin's fascinating life story and achievements: "An admirer of various cultures and an opponent of totalitarian ideologies, at the beginning of the 20th century Karlin was the first woman to travel alone and see a great deal of the world," the president said as she recalled that the author and researcher had penned more than 20 books describing her travels.

#### **New Amazon Prime** series filmed in Slovenia

LOS ANGELES (STA) — Two of Slovenia's most popular tourist destinations, Kobarid and Bovec, are featured in a new spy/thriller series, "Citadel," airing on Amazon Prime. The first two episodes of the series aired April 28.

With a production cost of \$300 million, "Citadel," Amazon's second-mostexpensive series to date, was filmed in Slovenia, England, Spain, Morocco, and the U.S. The series is produced by Joe and Anthony Russo, creators of Marvel's "Avengers: Endgame" and "Captain America: The Winter Soldier."

"The production team selected Bovec and Kobarid because both are surrounded by mountains, Kanin and Stol, respectively," according to thecinemaholic.com, a film and entertainment website.

The plot of "Citadel" revolves around a spy couple, portrayed by Richard Madden and Priyanka Chopra Jonas, who are forced to erase their memories to stop an antagonist intelligence agency, Manticore, from establishing a new world order. The series' first season includes six 40-minute episodes.





## SNPJ Scholarship Award Program A potential benefit of \$3,200 for Society members



### **ELIGIBILITY:**

To be eligible for an SNPJ Scholarship, the student must meet the following require-

- Be an SNPJ member for at least two years
- Have a \$5,000 minimum permanent life insurance policy in place (\$2,000 if purchased prior to January 1996)
- · Enroll as a full-time (at least 12 credit hours) or part-time (at least 6 credit hours) student at an accredited college, university or trade school

TYPES OF SCHOLARSHIPS: All requirements MUST be satisfied in order to qualify for the following scholarships:

### **Full-Time Student**

- · Attend school as a full-time student
- Minimum of 12 credit hours/semester

### **Part-Time Student**

- · Attend school as a part-time student
- Must declare a major (six to 11 credit hours/semester)

SNPJ Approved Activity: Participation at social and athletic events, attend the SNPJ Young Adult Conference, attendance or service at meetings and conferences, attend or volunteer at special Lodge events, write an article to be published in PROSVETA, participate in an SNPJ athletic tournament (bowling, golf, balina, bean bag toss, etc.), help organize a youth activity at your Lodge, hold an office in your Lodge, work as a counselor for Youth Roundup (must be interviewed and selected by Fraternal Department), volunteer to work during Slovenefest at the SNPJ Recreation Center, participate in an SNPJ-organized activity, perform community service on behalf of SNPJ (must be approved by Fraternal Department), recommend a new member to SNPJ.

### **APPLICATION PROCESS:**

- 1. Carefully review all SNPJ scholarship requirements.
- 2. Select the scholarship type for which you qualify.
- 3. Complete the scholarship application and deliver to your Lodge secretary for signatures.
- 4. Return the signed application, along with the following items, to the SNPJ Home Office by the August 1st deadline:
- · Copy of your last grade report or transcript (Transcripts do not have to be originals, but must show student name, semester, GPA, and number of credit hours completed).
- Short essay about fraternalism, the principles of SNPJ, and how they work in our Society and its Lodges.
- Brief history of your life, high school accomplishments, past awards and achievements, and college plans.
- Copies of your parents' and your 1040 tax forms for the previous year (if applying for the SNPJ Regular Scholarship).
- Copy of the Lodge secretary's letter (if applying for the SNPJ Activity Scholarship).

Please make sure all of the applicable items listed above are included when mailing your application. Failure to provide all required information at one time may result in denial of your application.

### **PAYMENT SCHEDULE:**

Full-time Students: Payments of \$400 each installment are made twice a year (first installment: February/March; second installment: August/ September) totaling \$800 per year. Applicants will receive payments for not more than eight (8) installments which may include graduate school.

Part-Time Students: Payments of \$200 each installment are made twice a year totaling \$400 per year. Part-time applicants who have declared a major shall receive payments equivalent to the TOTAL amount the full-time student receives for a maximum of 16 semesters.

Selection of students to receive the scholarship awards will be based on evidence of the applicant's school record, personality, character, SNPJ Approved Activity, the applicant's need for financial aid or academic achievement, and on the recommendation of the local Lodge of which he/she is a member.
