The numbers tell the tale: Fraternal benefit societies still thriving

IMPERIAL, Pa. — The results are in from the American Fraternal Alliance concerning the collection of data from all fraternal benefit societies that belong to the Alliance – and the results are impressive!

The Alliance reported that there are 6,265,370 fraternal benefit society members across the United States. These individuals participated in 1,693,044 acts of community service, spending 41,580,622 hours doing so and contributing \$413,839,941 to their communities and to charitable and humanitarian

organizations.

In addition, there were 421,178 fraternal/local lodge events hosted by these members, representing 5,301,319 hours and funding \$81,643,636 for these events. Fraternal benefit societies hold a total of \$520,555,545,387 of life insurance in force (that's \$520.5 billion, with a "b"), representing 7,439,233 policy holders.

So the next time someone asks you "What do fraternal benefit societies do?," you can tell them how much time, support, and monies we give back to our communities and those in need, and how many people we represent across the country.

Our SNPJ group was amazed at the breadth of services and support available to the families. They have at their disposal a variety of rooms

and outdoor spaces for relaxation, play, to complete job and communication demands, to prepare meals, do laundry, and take advantage of supportive counseling and information.

Our own Marcia Leathers sat down at the piano located in the large living room area to play a few tunes to offer inspiration to guests.

The Ronald McDonald House is highly organized and very clean, staffed by employees, volunteers, and some folks gaining experience credits toward a particular education goal.

Various community groups help support the facility; in particular, the San Manuel Band of Indians in the area. Lodge 723 was pleased to make a recent donation of a significant amount as part of the Slovene Hall sale proceeds. There is an acknowledgment of that financial support in one of the rooms, and the Lodge has received notes from a number of the families who have used that particular room.

IMPERIAL, Pa. — The Home Office staff encourages all SNPJ members and agents to register for access to the new SNPJ Portal that was launched in September. The portal can be used by policy owners to review information about their SNPJ life insurance policies and annuities. Agents can use the portal to check on their existing business, pending policies and updates.

To register for the SNPJ Portal, you must access the SNPJ website, *snpj.org*, and click on any of the "SNPJ Portal" links. You must be a policy owner or an agent to access the portal. Policy owners will need to know at least one of their policy and/or annuity numbers, and provide their name, date of birth, and social security number. Once registered, members can access policy information that Home Office staff members cannot provide over the phone.

Slovenia hoping to improve student nutrition

LJUBLJANA (STA) — Slovenia's National Institute of Public Health (NIJZ) recently launched a campaign to help college students, many of whom eat out often, choose healthier and more balanced meal options.

The NIJZ indicates that a third of all students in Slovenia eat fast food once a week, which makes for a calorie-dense but nutritionally poor diet.

Slovenia has long had a meal subsidy policy in place for college students, through which students can eat for a reduced price in participating restaurants. "The problem is that the program subsidies go to restaurants, where financial viability is key, instead of public kitchens, which can follow healthy nutrition principles more easily," an NIJZ expert was quoted as saying in a press release.

The NIJZ has now developed a classification system in a project co-funded by the Health Ministry. Healthy options offered by restaurants in the subsidy program will be labeled "Right Choice" by the NIJZ and the Tourism and Hospitality Chamber. Restaurants that are not participating can also take part in the subsidy program.

As part of the project, dubbed "Bon Appetit, Student!," a workshop for restaurants was organized in Maribor in late September.

Plečnik Auditorium reopens in Tivoli Park

LJUBLJANA (STA) — In September, an open-air amphitheater originally designed by architect Jože Plečnik reopened in Ljubljana's Tivoli Park, serving as a new cultural venue following a reconstruction.

Situated in a clearing behind Tivoli Mansion, the Plečnik Auditorium was built in 1933 but was allowed to fall into a state of disrepair after the Second World War. Through the mid-1960s the venue hosted an open-air summer cinema, but the site became overgrown. The clearing is now surrounded by tall trees.

Following Plečnik's designs, wooden stairs that serve as seating, supported by a steel structure, were installed at the edge of the forest utilizing the natural slope of the terrain. At the bottom of the gently rising stairs is a lawn that serves as a stage overlooking the city, just as it did in Plečnik's design, with the exception that the master architect used gravel instead of grass.

The auditorium has been reconstructed by the Medprostor architectural firm. The lead architect said the team applied a minimal and reversible design to reinterpret the original amphitheater at its original location and within its original dimensions. In this way, the designers highlighted Plečnik's care for public space as one of the key values in his contribution to humanity's legacy.

A wooden footbridge and a pathway link the venue to the Švicarija Arts Centre and Tivoli Mansion, which is home to the International Centre of Graphic Arts (MGLC).

MGLC will be responsible for the management of the new venue, as well as the program and coordination of events. As a rule, these will be admission-free events. The first event held to inaugurate the Plečnik Auditorium was the opening of the 35th Ljubljana Biennial of Graphic Arts on Sept. 15.

The project to reconstruct the Plečnik Auditorium was launched in March 2022 and concluded in November 2022 at the price of EUR 376,000 (\$396,000).

Slovenian radio stations join Radioplayer platform

LJUBLJANA (STA) — Most Slovenian radio stations will be joining Radioplayer, an international radio technology platform available in 20 countries. The announcement was made in early October at Audiofestival, an event celebrating podcasts and other audio media.

"Radioplayer is a platform that provides easier access to audio content, such as radio programs, podcasts and on-demand content using a phone, smart speaker or any smart device," said Mirko Stular, acting director of Radio Slovenija, Slovenia's public broadcaster. "Slovenia will be the 21st country worldwide and the 20th in Europe to join Radioplayer, which is expected to be available in Slovenia on Dec. 1," Štular added.

At the initiative of Radio Slovenija, more than 40 radio stations, which represent almost 90 percent of the radio



market in Slovenia, will be joining the platform. They are hoping to expand to include all radio stations.

"With the Radioplayer project, we are also gaining access to automotive partners that we, as the Slovenian market, which is absolutely too small, cannot access alone," Štular explained, adding that because of Radioplayer Worldwide's ability to negotiate, the technology will also be available to Slovenian users in modern vehicles with internet access.

The project was endorsed by the Media Chamber at Slovenia's Chamber of Commerce and Industry (GZS) and the Culture Ministry. "[Ministry and chamber members] are aware of the importance of radio journalism and different radio genres and programs that all feature the spoken Slovenian language," said State Secretary Marko Rusjan.

Ancient dugout found in the Mura after floods

LJUBLJANA (STA) — The floods that wreaked havoc across Slovenia in early August have led to the discovery of a giant ancient dugout canoe in the northeast of the country. The 11-meter (36-foot) dugout was found on the bank of the Mura River. Experts say the vessel could date back to the late bronze and iron ages.

This assumption is based on the characteristics of the stern and the size of the dugout, which correspond to those of vessels used in Central and Western Europe in the late Bronze Age and Iron Age, when transportation needs increased due to demographic and economic jumps during the early first millennium B.C.

The dugout was discovered in mid-September by Ljubomir Zečević, an expert on natural and cultural heritage in the Prekmurje region. "Zečević immediately informed the director of the regional museum, archaeologist Branko Kerman, of the find," a representative from the Skupina Stik archaeology institute said. The dugout likely surfaced during the massive floods that hit the country in August and has been labeled a spectacular find.

Zečević, Kerman, and a conservator from the Institute for the Protection of Cultural Heritage visited the site to determine that the canoe was dug out of an oak tree with a hand tool. The find is said to be spectacular because of the length of the vessel – which is more than 11 meters – and an interesting and rare type of stern, ending in a massive vertical plank inserted into a groove.

The experts say that the original location of the dugout is difficult to determine, but it is almost certain that the floods couldn't have ripped the vessel out of the nearby plains. Rather, the dugout had probably rested in the sediments of the Mura riverbed upstream from the spot where it was discovered.

The Institute for the Protection of Cultural Heritage ordered that the dugout be transferred to a safe location. Several history and archaeology institutes, including members of the Archaeology Department of the Faculty of Arts in Ljubljana, joined forces to free the vessel from the riverbank.

"The dugout was secured and fastened to a support platform, on which it was moved downstream along the Mura to a spot from where it was lifted. It was then transported to Murska Sobota Lake, where it is currently stored at the bottom of the lake pending a decision on further conservation procedures," the Skupina Stik representative explained.

More remains of ancient Emona unearthed

LJUBLJANA (STA) — In September, new pieces belonging to the jigsaw puzzle of the first- to sixth-century Roman city of Emona were discovered in Ljubljana during the renovation of the SNG Drama national theatre house. While the excavation work started in mid-August and is expected to be completed in February, archaeologists are already busy uncovering the remains of a residential building and a road dating back to the third and fourth centuries, respectively.

The Slovenian Institute for the Protection of Cultural Heritage said the architecture of the residential premises, named Insula XVIII, indicates the remains of a central heating system. Carved sandstone support pillars, upon which rectangular stone slabs were mounted, were also discovered. At the time of use, warm air circulated underneath, thus providing subfloor heating.

A 14-meter (46-foot) wide road ran through the area. In the unearthed section, small personal objects lost by the inhabitants of Emona were discovered in the sediment, including a fibula (a brooch for fastening garments), a ring, and coins.

A representative from the Cultural Heritage Institute explained that archaeological research is presently being conducted within the walls of ancient Emona. Once completed at the current site, additional research will be conducted on several more residential buildings and roads.

The research is expected to provide additional insight into the urban development of the Roman city, especially its later phases of construction, thus providing information about life in Emona at the time of the decline of the Roman Empire, and in turn a better understanding of Roman life in the area of Slovenia.

Northern bald ibis spotted near Lake Cerknica

CERKNICA (STA) — A northern bald ibis, a large migratory bird long considered extinct, was spotted near Lake Cerknica, according to information from the Notranjska Regional Park. The bird was bred in Austria as part of a repopulation project and equipped with a GPS tracker.

Photographer Zoran Vidrih described the bird's route: "[The ibis] traveled from Austria to Venice, to the Trieste Gulf, across Istria to Pula, crossing the Kvarner Gulf to Rijeka, and then over Ilirska Bistrica and the Javorniki Hills to our lake."

The bird, named Paride, is a five-yearold male. It likely stayed at the lake for a day or two, then headed for its wintering grounds in Calabria, Italy, or even further south, Vidrih said.

The northern bald ibis once inhabited the Near East, Northern Africa and South and Central Europe, including Slovenia, as evidenced by old church fresco paintings depicting the bird. It disappeared from Europe more than 400 years ago, the Notranjska Regional Park wrote in a press release.

A small population survived in Morocco, Algeria, Turkey and Syria. As part of the "Life+ Reason to Hope" project, the bird is being reintroduced in Europe, mainly in Austria and Italy.

Exhibition recognizes production of Renault 4

NOVO MESTO (STA) — An exhibition marking the 50th anniversary of the launch of production of the Renault 4, also known as the Quatrelle, opened in early October in the museum collection of former car manufacturer IMV in Novo Mesto, where the Renault 4 was produced from 1973 to 1992.

The legendary car was produced in the IMV plant and later in its successor, Revoz, also in Novo Mesto, with almost 576,000 units having been built.

The exhibition draws attention to a major part of Novo Mesto and Slovenian technical history, and to the collection of vehicles manufactured by the IMV company and its successors. The exhibition was arranged by the Dolenjska Museum in cooperation with the Novo Mesto municipality and Revoz, the car assembly plant that currently builds the Renault Clio 5 and the Renault Twingo.

According to the exhibition organizers, the first Quatrelle was produced in France in 1961. It went on to become a universal "people's car" with 8.14 million units produced over a period of 31 years and was the best-selling model in Renault's history.

The first Renault 4 was assembled in Novo Mesto in February 1973. Two years later a wheel production line was launched, and IMV also installed the equipment for assembling car bodies. IMV then secured the contract to produce and assemble the chassis. In 1976, IMV opened a mechanical processing plant, producing an average of 23 bodies per day. By 1979, more than 100,000 bodies for the Renault 4 had been produced.

The milestone 400,000th body was reached in 1988, and the last Quatrelle to be produced in Novo Mesto was taken from the assembly line on Dec. 22, 1992, since the car no longer met then-current safety and environmental standards.







SNPJ Approved Activity: Participation at social and athletic events, attend the SNPJ Young Adult Conference, attendance or service at meetings and conferences, attend or volunteer at special Lodge events, write an article to be published in PROSVETA, participate in an SNPJ athletic tournament (bowling, golf, balina, bean bag toss, etc.), help organize a youth activity at your Lodge, hold an office in your Lodge, work as a counselor for Youth Roundup (must be interviewed and selected by Fraternal Department), volunteer to work during Slovenefest at the SNPJ Recreation Center, participate in an SNPJ-organized activity, perform community service on behalf of SNPJ (must be approved by Fraternal Department), recommend a new member to SNPJ.

APPLICATION PROCESS:

- 1. Carefully review all SNPJ scholarship requirements.
- 2. Select the scholarship type for which you qualify.
- 3. Complete the scholarship application and deliver to your Lodge secretary for signatures.
- 4. Return the signed application, along with the following items, to the SNPJ Home Office by the August 1st deadline:
- · Copy of your last grade report or transcript (Transcripts do not have to be originals, but must show student name, semester, GPA, and number of credit hours completed).
- Short essay about fraternalism, the principles of SNPJ, and how they work in our Society and its Lodges.
- Brief history of your life, high school accomplishments, past awards and achievements, and college plans.
- Copies of your parents' and your 1040 tax forms for the previous year (if applying for the SNPJ Regular Scholarship).
- Copy of the Lodge secretary's letter (if applying for the SNPJ Activity Scholarship).

Please make sure all of the applicable items listed above are included when mailing your application. Failure to provide all required information at one time may result in denial of your application.

PAYMENT SCHEDULE:

Full-time Students: Payments of \$400 each installment are made twice a year (first installment: February/March; second installment: August/ September) totaling \$800 per year. Applicants will receive payments for not more than eight (8) installments which may include graduate school.

Part-Time Students: Payments of \$200 each installment are made twice a year totaling \$400 per year. Part-time applicants who have declared a major shall receive payments equivalent to the TOTAL amount the full-time student receives for a maximum of 16 semesters.

Selection of students to receive the scholarship awards will be based on evidence of the applicant's school record, personality, character, SNPJ Approved Activity, the applicant's need for financial aid or academic achievement, and on the recommendation of the local Lodge of which he/she is a member.
