ence represent their own Lodge, and have a voice and a vote during the conference. Surrogate delegates will become regular delegates if another Lodge approves them to serve as their regular delegate, thus gaining

All delegates, both regular and surrogates, will receive room and board. SNPJ will pay 100 percent of travel costs (including airfare) for regular delegates, including surrogate delegates who become regular delegates of another Lodge.

The surrogate must receive approval from the other Lodge to serve as their regular delegate. Surrogates who do not have the approval of another Lodge should be prepared to pay half of their airfare when making their airfare arrangements with TravelSearch, the Society's designated travel agency. SNPJ will not pay for rental vehicles.

If traveling by automobile, you will be reimbursed for mileage not to exceed 1,000 miles round trip. Regular delegates, including surrogate delegates who become regular delegates of another Lodge, will be reimbursed 100 percent of their mileage.

The surrogate must receive approval from the other Lodge to be their regular delegate. Surrogates who do not have the approval of another Lodge will be reimbursed half of their mileage unless they bring another surrogate and/or regular delegate with them in the vehicle.

Lodge secretaries received the Young Adult Conference delegate election forms in a recent mailing. There are some important deadline dates that Lodge secretaries and any members interested in attending this conference should be aware of.

Lodges must turn in their Young Adult Conference Delegate Election Forms by April 30. Any eligible member interested in attending the Young Adult Conference must contact their Lodge secretary to ensure that their name is included on the election form. Be sure to provide your e-mail address to your Lodge secretary; correspondence about the conference will be handled electronically as much as possible.

Once the election forms are received at the SNPJ Home Office, all delegates will receive an introductory packet via e-mail. This packet will include a general information sheet, a tentative agenda for the weekend, and a Young Adult Delegate Registration Form.

The registration form must be completed by the delegate and returned to the SNPJ Home Office no later than May 15. Return of the registration form completes the Young Adult Conference registration process.

All delegates must turn in a registration form by the deadline date; otherwise, they may be replaced by an alternate or surrogate delegate.

#### A climate office for municipalities and regions

LJUBLJANA (STA) - In mid-November, when a three-year contract on a public-private partnership was signed, Slovenia's Ministry of the Environment, Climate and Energy announced that a climate office for municipalities and regions will be formed to help areas adjust to climate change and increase their climate resilience.

The contract was signed by Minister Bojan Kumer and Gregor Macedoni, president of the Association of Municipalities and Towns (SOS), one of three associations representing Slovenia's municipalities, of which there are 212.

The project, estimated at EUR 199,000 (\$210,500), will continue until October 2026, with various activities extending after this period.

According to the ministry, Slovenia is the EU leader in terms of economic damage caused by extreme weather, which reached EUR 17.5 billion (\$18.5 billion) for the period 1980-2023. The ministry thus believes that measures should be introduced to allow the safe and sustainable development of local communities.

One of the project's main goals is to strengthen municipal administrations to be better equipped to plan adaptation measures, such as directing the population away from at-risk areas and increasing the resilience of infrastructure to flooding, heat waves and other weather extremes.

"[The project] is the result of longterm efforts by the SOS and the ministry," Macedoni said. "The office will offer municipalities support in climate change adjustment. It will help them prepare projects and organize training and consulting, while enabling a more effective cooperation with government agencies and other institutions," he added.

The office will publish brochures on adaptation at the local level, produce a monthly newsletter, launch a climate website presenting up-to-date information, and create a catalog of best practices. A key focus will be on areas under municipal jurisdiction, such as the management of residential areas and infrastructure adaptation to reduce the risk of climate extremes.

#### National archives moved to new premises

LJUBLJANA (STA) — The new premises of the Archives of the Republic of Slovenia opened Nov. 15, 2024, as Culture Minister Asta Vrečko visited the renovated and expanded former military barracks on Poljanska Road in Ljubljana, which itself has an interesting past. The archives in their entirety are now finally under one roof.

Vrečko said that the Archives of the Republic of Slovenia "deserve to be in new representative premises because they are the country's top archival institution." The Archives "keep all our history, the foundations of our statehood, and the documents that have taken us to where we are as a state, community and society," she said.

"Since the perception of archives in society has changed with the severe flooding [in 2023], five new regional archive storage facilities will be built," she announced. Minister Vrečko also said that archives were a "mirror of [Slovenia]," and those working in them are the guardians of not only the archival material, but also of memories.

Andrej Nared, the director of the Archives, is happy that the Archive finally moved to the complex that the government designated for the institution 30 years ago. The portion of the building that hosts the storage facilities was renovated in the early 2000s; a separate part of the complex was left untouched. The renovation of that section started in March 2022. The newly renovated area includes an exhibition venue, a reading room, restoration and conservation shops, a library, and offices for the staff.

The Archives were formerly housed at several locations in Ljubljana, and the material had long outgrown its main location, the Gruber Mansion in the Prule borough, which had been the seat of the Archives for seven decades.

According to Nared, this is the first time since 1990 that all Archives employees are under one roof. He hopes the new premises will be "a brighter mirror of the attitude of Slovenian society and the [country] toward archival heritage." He noted that the Archives keep around 30,000 meters (98,425 feet) of archival material, the oldest items dating back to the ninth century.

The former military barracks were lion (\$6.2 million) Horizon Europe EU



built in 1899 under Austro-Hungarian rule and were used for military purposes until Slovenia gained independence in 1991. During independence efforts in the late 1980s, the building served as barracks for the Yugoslav People's Army and also housed a military court.

Since the building is protected as cultural heritage, the renovation was completed under strict supervision of the national Institute for the Protection of Cultural Heritage.

#### Slovenia joins EU Clean Hydrogen Partnership

BRUSSELS, Belgium (STA) — Slovenia has signed a cooperation memorandum with the EU Clean Hydrogen Partnership. In late November, the Slovenian Ministry of Spatial Planning, Climate and Energy said in a statement that cooperation reinforces Slovenia's commitment to advancing the North Adriatic Hydrogen Valley project, along with its renewable energy targets.

"We want to further our capacities and exchange of knowledge for a more effective development and introduction of hydrogen technologies in Slovenia," said Tina Seršen, a state secretary at the Ministry of Spatial Planning, Climate and Energy, after signing the document in Brussels.

Cooperation in the partnership will grant Slovenia access to support in improving capacities, exchange of experience, and the sharing of know-how and funding management, all of which will contribute to developing an effective hydrogen ecosystem. "Breakthrough green technologies will create significant opportunities for the corporate sector," the ministry added.

The Clean Hydrogen Partnership is a public-private partnership that provides support for research and innovation in hydrogen technology. By 2027 the project will have received EUR 1 billion (\$1.04 billion) in EU funds, and at least the same amount of private investments.

The EU also announced an additional EUR 200 million (\$208.6 million) for the partnership in order to double the number of hydrogen valleys by 2025.

#### Koper joins Città del Vino winemaking network

KOPER (STA) — Koper will be the first municipality in Slovenia to join the Italian association Città del Vino, a network of local communities dedicated to winemaking. The membership agreement was signed Nov. 16, which is why one of the local St. Martin's Day celebrations was held a week later than typical.

Koper representatives hope that by becoming part of Città del Vino, the municipality's winemakers will find it easier to penetrate new markets. It also expects a raised profile as a wine destination, and to strengthen its winemaking identity and sustainable development efforts in cooperation with Italian areas

committed to the same goal. Città del Vino members have access to funding, projects and training programs organized by the association. In addition, Città del Vino supports events and festivals at which winemakers meet and work to expand into new markets. Established in 1987, the association brings together some 500 municipalities, cooperatives and wineries.

The Altroke St. Martin's Day celebration in Koper, marking the end of the wine harvest season, was held a week later than in most other Slovenian regions to coincide with the signing of the membership agreement.

#### Jožef Stefan Institute opens SQUASH project

LJUBLJANA (STA) — In October, the Jožef Stefan Institute (IJS) presented a EUR 11.5 million (\$12.4 million) project that aims to attract quantum science and technology researchers. SQUASH (Slovenian Quantum Science Hub) will recruit 40 postdoctoral researchers from around the globe; the IJS hopes the project will also improve its research excellence and competitive edge.

The project received a EUR 5.7 mil-

grant earlier in 2024; the remainder of the funding will be provided by Slovenia's Ministry of Higher Education, Science and Innovation.

The five-year SQUASH project will be launched in March. The lead partner is the University of Ljubljana; the IJS will coordinate the program. SQUASH will bring together 45 academic and non-academic associate partners from Slovenia, Europe and beyond.

IJS director Boštjan Zalar hailed SQUASH as one of the biggest scientific research projects in Slovenia with strong financial backing. "An important goal is to attract foreign researchers to Slovenia and encourage Slovenian scientists working abroad to return," Zalar said as he presented the project.

"The idea is to train innovative experts in quantum research and technologies to prepare them for the challenges of the second quantum revolution," SQUASH coordinator Andrej Zorko added.

Participating researchers will be awarded fellowships to improve their research skills in four key multidisciplinary areas. The first area is quantum theory, in which they will research open questions of quantum physics. The second area is quantum materials: researchers will look for new concepts based on quantum mechanics that could lead to new functionalities of materials. The third area is the development of various quantum technologies, and the fourth is the development of quantum

"Some other projects will be carried out as part of SQUASH, such as improving food technology and sustainable development in the fight against climate change; and developing more ethical, human-friendly and sustainable AI technologies," according to Zorko.

IJS representative Rok Žitk said that quantum technologies offer many opportunities in various fields, and SQUASH is an important milestone encouraging their development.

#### A new floating mill and ferry on the Mura River

BELTINCI (STA) — In late October a new floating grain mill and a traditional ferry were launched on the Mura River in northeast Slovenia, a EUR 450,000 (\$487,000) project that is expected to attract more visitors to the Island of Love. The island, created by river erosion, was very popular among tourists before the old mill collapsed in 2022.

The new mill was constructed as part of ReKult, a project designed to upgrade the river's cultural heritage near the Island of Love in the Prekmurje region.

Beltinci Mayor Marko Virag said the project had been co-financed with EU funds, along with funds the municipality received through a Slovenian Ministry of the Economy and Tourism award process. "The mill and the ferry are not only a symbol of the past, [they] are key to sustainable tourism that unites history, nature and modern approaches," Mayor Virag said. "They should enable visitors to experience the unique Mura, its history, and its impact on the lives of the people of Prekmurje," he added.

Cultural and educational programs will now be offered, one of which will be Miller's Day, when visitors can become a miller for a day to experience this bygone job.

As for the Love Island name, legend says that after WWI, Countess Maria Zichy was riding to the island one day and saw a handsome man. The man disappeared as she drew closer, but she continued to return to the island until she came across the man – the miller's son – again, and the pair fell in love. When their secret romance was revealed, the miller's son left the village never to be seen again, the countess swore never to marry, and she thus became the last countess at Beltinci Castle.

During the opening ceremony, a ribbon was cut by Mayor Virag, Economy Ministry State Secretary Dejan Zidan, and European Commission Representation director Jerneja Jug Jerše.

Židan said that of the five municipalities in Prekmurje that had secured recent funding from the ministry, Beltinci was the first to complete their project. Apart from the five municipalities, 12 private tourist entities in the region were awarded funding, which means that Prekmurje is in the midst a EUR 45 million (\$48.7 million) investment cycle.

Stressing the role of linking natural and cultural heritage on the island, Jug Jerše said she was happy the EU contributed funds for the project from the recovery and resilience program.


Hall events.

#### **APPLICATION PROCESS:**

- 1. Carefully review all SNPJ scholarship requirements.
- 2. Select the scholarship type for which you qualify.
- 3. Complete the scholarship application and deliver to your Lodge secretary for signatures.
- 4. Return the signed application, along with the following items, to the SNPJ Home Office by the August 1st deadline:
- · Copy of your last grade report or transcript (Transcripts do not have to be originals, but must show student name, semester, GPA, and number of credit hours completed).
- Short essay about fraternalism, the principles of SNPJ, and how they work in our Society and its Lodges.
- Brief history of your life, high school accomplishments, past awards and achievements, and college plans.
- Copies of your parents' and your 1040 tax forms for the previous year (if applying for the SNPJ Regular Scholarship).
- Copy of the Lodge secretary's letter (if applying for the SNPJ Activity Scholarship).

Please make sure all of the applicable items listed above are included when mailing your application. Failure to provide all required information at one time may result in denial of your application.

#### **PAYMENT SCHEDULE:**

Full-time Students: Payments of \$400 each installment are made twice a year (first installment: February/March; second installment: August/ September) totaling \$800 per year. Applicants will receive payments for not more than eight (8) installments which may include graduate school.

Part-Time Students: Payments of \$200 each installment are made twice a year totaling \$400 per year. Part-time applicants who have declared a major shall receive payments equivalent to the TOTAL amount the full-time student receives for a maximum of 16 semesters.

Selection of students to receive the scholarship awards will be based on evidence of the applicant's school record, personality, character, SNPJ Approved Activity, the applicant's need for financial aid or academic achievement, and on the recommendation of the local Lodge of which he/she is a member.


